SPIRITUAL LIFE OF THE CHURCH

Annual Report: Report from Rev Graham Hedger, Priest in Charge

When as Stewardship Advisor, I started working on finance issues with the benefice back in the autumn of 2017 I knew that this was a good benefice. I also know that to create a benefice from two existing groups of churches takes hard work, prayer and vision. The fact that we are where we are today is testimony to that hard work put in by my predecessor, the Revd Deirdre West, the church wardens, elders and others. My thanks goes to all of them for making my return to full time parochial ministry so easy and joyful.

At the Annual Parochial Church Meeting I will give a fuller report on the life of the benefice and individual churches. However, in our written report I want to highlight a few things.

As a benefice we have much to celebrate:

• We have six, soon to be seven elders. They lead services, offer pastoral support to many people and are an immense support to me as we share ministry together.

- One of the first things that I noticed at my first service was the excellent benefice choir. Their hard work and commitment makes the Benefice Service on the first Sunday of the month so special and uplifting. Sadly, only about half of the total of our worshipping congregations come to Benefice Services, just think how good it would be if that service was a full church, month by month. Our worship could be even more uplifting.
- The diocese has invited churches to set out their objectives for mission and ministry within the framework of Growing in God. It is immensely heartening to see that many of the objectives set a couple of years ago have been achieved. This is important, because all too often in the busyness of dealing with ancient buildings and finance we can lose sight of what it is all about.
- The way that people support other parishes at special events and services is commendable and bodes well for the future.
- It is a joy to have seven sets of bells that can be rung. A big thank you to the tower captains and teams of ringers who support one another and enable villages to be reminded that the church is at prayer.
- During the year the treasurers, wardens and PCCs have worked hard to ensure that the commitment made to pay the Centenary Share in full was indeed achieved. This is very heartening. Thank you to everyone who made that possible.
- I am very grateful to the Revd Canon Deirdre Parmenter and the Revd Canon Richard Ginn for their hard work and support in taking services and offering pastoral support.

I thank everyone who has made a contribution to the life of our seven churches in the benefice. Whenever there are articles about the strength of the voluntary sector, they miss out the huge amount of work that people do in their local church. Whether you are an officeholder, serve on a committee, an organist, a bell ringer, church cleaner, flower arranger, magazine editor or deliverer or do any other the many tasks that go on in the church. Thank you. Your contribution is valued and appreciated.

It's a joy to walk into Kettleburgh church and see the new layout at the rear of the church. This hasn't happened overnight. Sadly, for a variety of reasons this has taken the best part of ten years. However, we now have a space at the back of the church around the font and level access which will benefit many. Thank you all who made that possible.

Small churches function well because there are people who are willing to do not just one thing but many things. I am especially grateful to John Bater as our only churchwarden; Jackie Clark who is both PCC secretary and also an elder, working not just in Kettleburgh but across the benefice; Bill Clark as vice chair of the PCC and Paul Baker who is treasurer to both Brandeston and Kettleburgh. Alongside them are others who serve on the PCC, assist with the church cleaning, flowers, magazine and many other tasks. Thank you for all you do.

I am grateful for the hard work and support of so many people who carry out many tasks which enable our church not merely to survive but flourish. During 2019 both as a PCC and as a benefice we will be seeking God so that we can indeed be ' flourishing congregations serving our communities'.

Children's Activities

Although we do not have any children who are regular attendees, children in our village who may wish to are encouraged to attend the Cosmic Club at Easton Church and other children's activities, such as the summer holiday club at Charsfield for primary age children.

Bells

During 2018 the bells were rung for services by ringers from Kettleburgh and Brandeston. It is becoming harder to ring for all available services due to few ringers and overlap of services with other parishes. Visitors from Lancashire rang a peal in April, and there have been a couple of quarter peals rung during the year. On 11th November local ringers rang the bells half muffled for the 100th year anniversary of the end of WWI. *Persephone Booth, Tower Captain*

FUND RAISING

Kettleburgh Village Fete

The annual fete on Saturday 9th June brought the whole village together. We thank Ron and Debbie Germain for their generosity in letting us use the garden at their Chequers pub. Over £3,000 was raised and divided equally between the village hall and church fabric fund. Once again large crowds came and had fun, attracted not only this year by our traditional stalls, games and the dog show, but also by the glorious sunshine.

Church Quiz Evenings

Two quizzes were held during the year, raising a total of £1186.40. This money was shared between Suffolk Family Carers, Children in Need and St Andrew's Church.

Kettleburgh Autojumble

The Autojumble is currently run three times a year for different charities, and gives generous donations to St Andrews Church fabric fund every year, as shown in the Financial Report. We acknowledge our thanks to the organisers for the funding they provide.

Suffolk Historic Churches Cycle Ride

Four cyclists took part in fundraising which realised £671.40 for the Suffolk Historic Churches Trust

Children's Society and Families in Need

£213.57 was collected in 19 individual's Children's Society Boxes, and the Christingle service raised a further £33. Christmas gifts from our Christingle service were taken to the Ipswich charity FIND (Families in Need).

Carol Singing

Carol singing accompanied by the Kettleleles took place in The Chequers this year instead of singing around the village. Ron and Debbie provided refreshments and a collection totalling £103.71 was sent to the East Anglian Children's Hospice.

Link to Hope Shoebox Appeal

15 shoeboxes of Christmas gifts were collected in Kettleburgh and sent to Eastern European Countries.

BUILDINGS AND CHURCHYARD

The Plans for Reordering the Church

The first phase of our reordering project was completed in May. We now have a completely level access from the south porch into the nave, a flexible space around the font and a gentle slope leading towards the east end of the church.

The re-ordering was dedicated by the Archdeacon on Sunday 14 October.

An archaeological survey was completed as part of the work. Go to the Kettleburgh Village Website to read a copy.

The total cost of this part of project was just over £40,000. Over the many years that we have waited to get started we have built up a 'Fabric Fund'- a restricted fund which is used for keeping the church in good condition. The proceeds from many of our village fundraising events have helped to build up this fund. Some of this money will be used to pay for the work. We were also successful in obtaining grant funding from the following organisations for which we are most grateful: The Ganzoni Trust; The Mills Charity; Suffolk Historic Churches Trust; The Church of England Centenary Fund. Thanks are also due to a number of anonymous donors within the parish.

Plans are in hand to provide some new furniture at the back of the church.

The second phase will be to add some new doors to the south porch and to repair and open the door opposite our main entrance, in the north wall. The third part of this project is to provide accessible toilet and storage facilities.

Cleaning and Flower Rotas

The regular weekly cleaning of the church building continued to be performed by a dedicated band of volunteers. Flowers were arranged on the altar on a weekly basis and, at major services throughout the year, members of the flower rota rose to the challenge of decorating the rest of the church by creating arrangements in tune with the season.

Fabric, Goods and Ornaments

The building is generally in a good state of repair apart from a few patches where plaster has flaked off the internal walls and all furnishings and ornaments are in good order.

Churchyard Maintenance

The churchyard has been kept tidy while allowing certain areas to be left for wild flowers to bloom and seed. The grass has been kept short in the area of recent graves on the north side of the church to make it easier for people to visit graves and lay flowers. The Parish Council continues to cover the cost of church yard maintenance, which is undertaken regularly during the summer months by a contractor.

POLICIES

Disability Discrimination

Large print booklets for the Common Worship communion service are available in the church. St Andrew's now has a completely level access from the south porch into the nave.

Health and Safety

The church building and churchyard are regularly inspected and a report is considered by the PCC. Electrical items and fire extinguishers are inspected by qualified persons. There is a separate Health and Safety Policy for the church tower and for bellringers.

INDEPENDENT EXAMINER'S REPORT TO THE PCC OF ST ANDREW'S CHURCH, KETTLEBURGH, FOR THE YEAR ENDED 31 DECEMBER 2018

This report on the financial statements of the PCC for the year ended 31 December 2018 which are set out on page 1, is in respect of an examination carried out in accordance with the Church Accounting Regulations 2006 ("the Regulations") and section 43 of the Charities Act 1993 ("the Act").

Respective Responsibilities of PCC and Examiner

As members of the PCC you are responsible for the preparation of the financial statements. You consider that the audit requirement of the Regulations and section 43(2) of the Act do not apply. It is my responsibility to issue this report on those financial statements in accordance with the terms of the Regulations.

Basis of Independent Examiner's Report

My examination was carried out in accordance with the General Directions given by the Charity Commission under section 43(7)(b) of the Act and to be found in the *Church Guidance*, 2006 edition, issued by the Finance Division of the Archbishops' Council. That examination includes a review of the accounting records kept by the PCC and a comparison of the accounts with those records. It also includes considering any unusual items or disclosures in the financial statements and seeking explanations from you as trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

Independent Examiner's Statement

In connection with my examination, no matter has come to my attention:

Financial Report 2018

Unrestricted receipts in 2018 were £13037.46. This was a decrease of £294.55 on 2017. There was an increase in Collections but falls in Gift Aid. Tax recovered on Gift Aid and Fundraising. Unrestricted payments were £12137.09. This was an increase of £12.49. The excess of unrestricted receipts over payments was £900.37. Major works were carried out in 2018 totalling £35048.49. Grants from various bodies and donations from the village came to £18899.32. My thanks go to Jackie Clark for all her work in obtaining the grants.
